Opening Comments – Drew Logan, Jaime Goncalves, Mike Riley, Tina MacConnell, Sabine St. Pierre Drew cheers to new board members. Drew suggested mini orientation for new members to get up to speed – 1:1 call with each of the board members for advice and what works well, individual perspective.

- Annual meeting recap
 - Tina thought it went well. Great attendance.
 - o Best attendance ever.
 - Is there a learning curve for Zoom for some members? Tina did not get any complaints about the Zoom platform.
 - → Less complaining about weeds not going through than expected. A complaint from member that voted it down felt that they weren't welcome. Discussion of efforts that have been made to make sure that no members are excluded or not welcome due to their opinions on herbicides.
 - The executive board individually supports herbicides, but we never pushed it on people. We have not voted on if we support herbicides as LMPA since 2015 but the e-board did vote.

- Weed management recap. - Mark Sexton

- Would like to get the lake biologists involved that lives on Downey that commented at the general meeting.
- Meeting with the CIG on Tuesday. Jaime to update. He is resigning as of July 1. Discussed the vote and how it went down. What was the rejection based on? Hopkinton bylaws and one on state requirements.
 There is an appeal process and we have 30 days to appeal through the DEP.
- Every single other committee, CIG and Select board voted in favor of the herbicide, and ConCom voted it down.
- Drew is going to draft write a letter and circulate with CIG encouragement. Sending the letter will put it on the agenda of the Select board meeting.
- o Town buying Spindel Island. We don't know what the price is. We need to pack the house for the next town meeting to get the approval to buy.

- Discussed Cornhole options
 - Social distancing, groups no bigger than 10
 - Zoom meeting with social committee
- o Light up the Lake July 3rd
- Boat Parade July 4th (Rain date July 5th)

 - How to set up voting and get it out to the members.
 - What is the route? Usually falls apart on the North Side. Suggested droid image with arrows to show flow.
