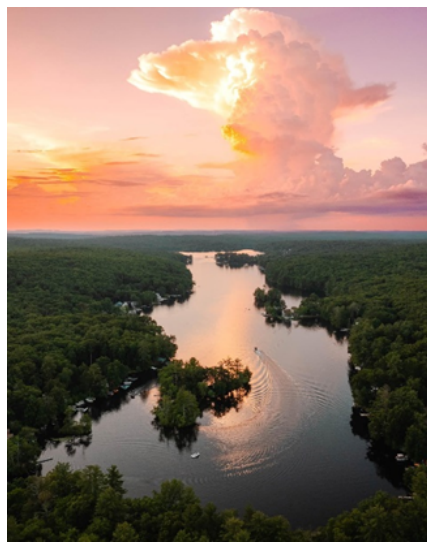

## THE MISSION OF THE LMPA:

- Dedicated to the preservation and protection of Lake Maspenock and its watershed for future generations.
- To provide monitoring for water quality, invasive vegetation, and other environmental concerns.
- To offer lake safety guidelines as well as educational and community building opportunities for individuals and families.

## ONGOING LMPA PROJECTS:

**Weed Control** – Working with the towns of Hopkinton, Upton and Milford as well as the Town of Hopkinton Lake Maspenock Weed Advisory Committee (CIG) to execute the Lake Maspenock Aquatic Vegetation Management and Control Plan which was developed by the Advisory Committee under guidance from the DPW and Board of Selectmen. A copy of this plan can be found on our website.

**Water Quality** – A comprehensive monitoring plan was also developed by the Advisory Committee. Volunteers from the LMPA will be performing the monitoring activities in accordance with this plan. The Monitoring Plan can be found as part of the same link above. Monitoring results, which will include water quality and weed assessments, will be regularly posted to the website and Facebook.

**Watershed Management** – the LMPA is also working with the Advisory Committee to develop a comprehensive watershed management plan.

**Dam Maintenance** – working with the towns of Hopkinton, Upton and Milford to advise, monitor and contribute to ongoing maintenance of the dam.
